The pre-bid meeting for Tender for **Supply, Installation, Configuration, Commissioning, Testing, Maintenance and Support of NAS Storage at IUCAA, Pune** was held on 06th September, 2024 at 1100 hrs in Bhaskara-1. The following committee members were present:

As per the tender document 100% payment shall be made after successful supply, installation, configuration, testing and commissioning of equipment. However, the bidders are requested for release of 80% payment after successful supply of the equipment and remaining 20% after successful installation, configuration, testing and commissioning of the equipment.

Considering the request from bidders, the committee has agreed for payment terms as follows:

- 1. 60% payment after successful supply of the equipment
- 2. 40% after successful completion of installation, configuration, testing and commissioning of the equipment.

Therefore, approval is sought for modification in the payment clause as per above.
